- Education Qualifications

- Agreement of Lease and License if premises are rented.
- Caste Certificate
- Rs. 2500/- as Security Deposit if opening of FPS is approved

releases advertisement in the local dailies inviting applications from the concerned area. Period of 30 days is given to submit
